

TERMS AND CONDITIONS
OF PROBATION

TO: DEFENDANT ROY STROM

It is the ORDER OF THE COURT that during your term of probation, you shall comply in all respects with the following terms and conditions:

1. You must obey all law and follow all lawful and reasonable instructions which are given to you by your probation officer.
2. You must report as directed by your probation officer.
3. You must report any change of address or change of employment within 48 hours.
4. You must not leave the island of Kauai at any time without first obtaining permission from your probation officer.
5. You must permit your probation officer to visit your home and place of employment at all reasonable times.
6. Your further SPECIAL conditions of probation are as follows:
 - a. You are sentenced to one year in the Kauai Community Correctional Center, however it will be suspended during the period of your probation.
 - b. You are to continue participating in all the programs as spelled out in the family court proceedings in the same matter.

NOTE: If your whereabouts become unknown to your probation officer because of your failure to keep him informed, the court may order your arrest. Any failure by you to comply with all of the terms and conditions of probation will mean that the court can revoke your probation and sentence you to prison, or change or add to the terms of probation.

The foregoing terms and conditions of probation have been explained to me and I fully understand them and agree to abide by them in every way, and understand the consequences. I have received a copy of these terms and conditions of probation.
