JUDGMENT

The above-named defendant having entered a plea of not guilty and having been found guilty of the above charges upon trial by jury on July 19, 1983,

IT IS ADJUDGED that said above-named defendant has been convicted of and is guilty of the offense of RAPE IN THE FIRST DEGREE (COUNT I), KIDNAPPING (COUNT II), SEXUAL ABUSE IN THE FIRST DEGREE (COUNT III) and THEFT IN THE FIRST DEGREE (COUNT IV) committed in the manner and form set forth in the charge.

IT IS THE JUDGMENT AND SENTENCE of the Court that defendant be committed to the custody of the Director of the Department of Social Services and Housing as follows until released in accordance with law: COUNT I, TWENTY (20) YEARS, COUNT II, TWENTY (20) YEARS, COUNT III, FIVE (5) YEARS, and COUNT IV, FIVE (5) YEARS, said sentences to run concurrently with each other and consecutive to the sentence imposed in Cr. No. 53332.

IT IS FURTHER ORDERED that defendant be sentenced to a mandatory minimum term of imprisonment of FIVE (5) YEARS under HRS §706-606.5, to run consecutive to the sentence imposed in Cr. No. 53332.

IT IS FURTHER ORDERED that defendant make restitution to the victim in the amount of \$2,050.00 after his release from incarceration in a manner to be determined by the Hawaii Paroling Authority.
