- 1 1. The defendant shall obey all laws.
- 2 2. The defendant shall abide by all the general conditions of probation.
- 3 3. The defendant shall pay probation supervision fees of \$25.00 a month
- 4 at the direction of the probation officer.
- 5 4. The defendant shall submit to sex offender evaluation as directed by
- 6 his supervising probation officer.
- 7 5. The defendant shall complete any treatment as recommended by the
- 8 evaluation and be financially responsible for such treatment.
- 9 6. The defendant shall complete an anger control counseling program if
- 10 deemed appropriate by his supervising probation officer.
- 11 7. The defendant shall have no contact with the victim or her
- 12 family.
- 13 8. The defendant shall serve 10 days in the Hood River County Jail with
- 14 credit for 10 days previously served.
- 15 9. The defendant shall pay a \$100.00 Unitary Assessment.
- 16 10. The defendant shall pay a compensatory fine to the victim,
- 17 in the amount of \$1,000.00.
- 18 11. The defendant shall pay restitution in the amount of \$779.30 to
- 19 Skyline Hospital, \$181.00 to Dr. Gregory Zuck, and \$1,000.00 to the
- 20 Oregon Department of Transportation.
- 21 12. The defendant shall pay the financial obligations ordered in this case
- 22 at the direction of his supervising probation officer.

15. The defendant shall have no contact with any female child under the age of 18 years without the prior approval by his supervising probation officer.


