


OF PROBATION

TO: RANDY UDAUNDO:

IT IS THE ORDER OF THE COURT THAT DURING YOUR TERM OF PROBATION, YOU SHALL COMPLY IN ALL RESPECTS WITH THE FOLLOWING TERMS AND CONDITIONS:

1. You must not commit another federal or state crime during the term of probation;
2. You must report to your probation officer as ordered by the Court or by your probation officer. Within one (1) business day of your release from confinement, you are to report immediately to:

3. You must remain within the jurisdiction of the court unless granted permission to leave by the Court or a probation officer, and when applicable, in compliance with interstate compact requirements;
4. You must notify a probation officer prior to any change in address, telephone number, or employment;
5. You must notify a probation officer promptly if arrested or questioned by a law enforcement officer; and
6. You must permit your probation officer to visit you at your home or elsewhere as specified by the court.
7. Your further special conditions of probation are as follows:

AS TO COUNTS I AND II: SEXUAL ASSAULT IN THE SECOND DEGREE:

- A. You shall follow all reasonable instructions which are given by your probation officer.

(SEE ATTACHMENT 'A' FOR CONTINUATION OF TERMS AND CONDITIONS OF PROBATION)

NOTE: IF YOUR WHEREABOUTS BECOME UNKNOWN TO YOUR PROBATION OFFICER BECAUSE OF YOUR FAILURE TO KEEP HIM INFORMED, THE COURT MAY ORDER YOUR ARREST. ANY FAILURE BY YOU TO COMPLY WITH ALL OF THE TERMS AND CONDITIONS OF PROBATION WILL MEAN THAT THE COURT CAN REVOKE YOUR PROBATION AND SENTENCE YOU TO PRISON, OR CHANGE OR ADD TO THE TERMS OF PROBATION. YOU ARE FURTHER INFORMED THAT PER HRS 134-7, YOU ARE PROHIBITED FROM OWNING, OR POSSESSING ANY FIREARM OR AMMUNITION.

I HAVE RECEIVED A COPY OF THESE TERMS AND CONDITIONS OF PROBATION AS ORDERED BY THE COURT.

TERMS AND CONDITIONS OF PROBATION
(CONTINUATION)

- B. You shall be sentenced to jail for a period of THIRTY (30) DAYS in addition to time already served; mittimus to issue forthwith.
- C. You shall pay a \$410.00 Crime Victim Compensation fee (\$205.00 for each count).
- D. You shall pay a Probation Services fee of \$150.00.
- E. You shall provide buccal swab samples and print impressions of each hand, and, if required by the collecting agency's rules or internal regulations, blood specimens, required for law enforcement identification purposes.
- F. You shall pay the actual cost of the DNA analysis to the DNA registry fund.
- G. You shall participate in all programs of rehabilitation as may be recommended by your probation officer at your expense, including but not limited to an individual and/or family counseling until clinically discharged with the approval of your probation officer.
- H. You shall obtain a psychosexual evaluation and participate in sex offender treatment, assuming all costs of treatment until clinically discharged with the approval of the Adult Client Probation Services. The treatment agency/therapist shall submit monthly progress reports to the Adult Client Probation Services.
- I. You shall execute a written waiver of confidentiality for any assessment, treatment, counseling, therapy, or other programs ordered as a condition of probation.
- J. You shall not possess any pornographic, sexually oriented, or sexually stimulating visual, auditory, telephonic, electronic media and computer programs or services or any inappropriate material as clinically defined by your primary therapist; and that whenever specific and articulable facts exist giving rise to a reasonable suspicion on the part of the probation officer that you are concealing such materials on your person, at your residence, vehicle, or other sites or property under your control, you shall submit to a search, with or without a warrant, by the probation officer at reasonable times and when conducted in a reasonable manner.
- K. You shall submit to a plethysmograph and/or polygraph at your own expense when directed by your probation officer.
- L. You shall be prohibited from having any _____ including at her place of employment, without the prior approval from your probation office..
- M. You shall provide two samples of blood for DNA analysis within 30 days to be arranged by the Department of Public Safety.
- N. You shall abide by any curfew, travel, and leisure time restrictions imposed by the probation officer.
- P. You shall sign a Waiver of Extradition.
- Q. You shall submit to being photographed by the Adult Client Probation Services for identification purposes.

Jail terms to run concurrently.

Payment of the Crime Victim Compensation fees/Probation Services fee, and other fees shall be paid in the amount of \$100.00 per month with the first payment due 60 days after incarceration, thereafter payments shall be due on the first business day of each month until paid in full. Payments shall be applied in the order as prescribed in HRS §706-605(6).
