

FINAL JUDGMENT AND SENTENCE OF THE COURT:

- COUNT 3: KIDNAPPING (§707-720(1)(d), H.R.S.):
 TEN (10) years with a mandatory minimum of three (3) years and four (4) months.
- COUNT 4: ASSAULT IN THE 2ND DEGREE (§707-711(1)(d), H.R.S.):
 FIVE (5) years with a mandatory minimum of one (1) year and eight (8) months.
- COUNT 5: ASSAULT IN THE 1ST DEGREE (§707-710(1), H.R.S.):
 TEN (10) years with a mandatory minimum of three (3) years and four (4) months.
- COUNT 6: SEXUAL ASSAULT IN THE 1ST DEGREE (§707-730(1)(a), H.R.S.):
 TWENTY (20) years with a mandatory minimum of six (6) years and eight (8) months.
- COUNT 7: SEXUAL ASSAULT IN THE 1ST DEGREE(HRS §707-730(1)(a), H.R.S.):
 TWENTY (20) years with a mandatory minimum of six (6) years and eight (8) months.
