


**TO: DEFENDANT SHIVA ALI FURTADO**


It is the ORDER OF THE COURT that during your term of probation, you shall comply in all respects with the following terms and conditions:

1. You must obey all law and follow all lawful and reasonable instructions which are given to you by your probation officer.
2. You must report as directed by your probation officer.
3. You must report any change of address or change of employment within 48 hours.
4. You must not leave the island of Hawaii at any time without first obtaining permission from your probation officer.
5. You must permit your probation officer to visit your home and place of employment at all reasonable times.
6. Your further SPECIAL conditions of probation are as follows:

**NOTE:** If your whereabouts become unknown to your probation officer because of your failure to keep him informed, the court may order your arrest. Any failure by you to comply with all of the terms and conditions of probation will mean that the court can revoke your probation and sentence you to prison, or change or add to the terms of probation.

The foregoing terms and conditions of probation have been explained to me and I fully understand them and agree to abide by them in every way, and understand the consequences. I have received a copy of these terms and conditions of probation.

Further Special Conditions - Continued

- A. You shall be committed to the custody of the Director of the Department of Public Safety for incarceration for a period of one (1) year. Mittimus to issue August 16, 1999 at 12:00 p.m. Should you be accepted into Sand Island or Habilitat residential treatment program, the one (1) year shall be suspended. You shall waive all confidentiality between your treatment provider and the Adult Probation Division and shall comply with all treatment program constraints and all future treatment recommendations until clinically discharged.
- B. Within forty-eight (48) hours of sentencing, you shall register as a sex offender with the Hawaii County Police Department and shall be subject to DNA blood sampling pursuant to law and shall follow all other legal requirements.
- C. Within fourteen (14) days of release from incarceration or residential treatment, you shall make contact and enroll in the Transition Network sex offender treatment program. You shall attend and fully participate in this program to include any and all future polygraph/plethysmograph testing at your own expense until clinically discharged.
- D. Within thirty (30) days of your release from incarceration or residential treatment, you shall obtain and maintain full-time, gainful employment and remain employed throughout the term of your probation and you shall not secure employment where unsupervised female minors under the age of eighteen (18) may congregate.
- E. You shall refrain from the use and/or possession of illegal or unprescribed drugs and alcohol. You shall be subject to random testing of your blood, breath and/or urine for the presence of illegal and/or unprescribed drugs and/or alcohol and shall present yourself for testing within two (2) hours of any request by your probation officer.
- F. You shall have no contact with the victim or members of her immediate family. However, this does not apply to , provided she contacts you.
- G. You shall have no contact with any minor female under the age of eighteen (18). You shall not frequent any establishments where minor females congregate, to include arcades and carnivals. However, you may attend movies and sports events if an adult accompanies you at all times.
- H. You shall not enter any bars or taverns where alcohol is the primary source of income and you shall not reside in a residence where alcohol is kept or illegal drugs are used.

- I. You shall refrain from the purchase or possession of any adult/child pornography. This includes adult movies whether on theater, video, or TV, books and magazines and/or any computer related pornography.
- J. You shall pay a fine of \$500.00 to the Criminal Injuries Compensation Commission within fifty-six (56) months of August 2, 1999.
