

TERMS AND CONDITIONS  
OF PROBATION

TO: DEFENDANT JOSEPH HINTON

It is the ORDER OF THE COURT that during your term of probation, you shall comply in all respects with the following terms and conditions:

1. You must obey all law and follow all lawful and reasonable instructions which are given to you by your probation officer.
2. You must report as directed by your probation officer.
3. You must report any change of address or change of employment within 48 hours.
4. You must not leave the island of Hawaii at any time without first obtaining permission from your probation officer.
5. You must permit your probation officer to visit your home and place of employment at all reasonable times.
6. Your further SPECIAL conditions of probation are as follows:

NOTE: If your whereabouts become unknown to your probation officer because of your failure to keep him informed, the court may order your arrest. Any failure by you to comply with all of the terms and conditions of probation will mean that the court can revoke your probation and sentence you to prison, or change or add to the terms of probation.

The foregoing terms and conditions of probation have been explained to me and I fully understand them and agree to abide by them in every way, and understand the consequences. I have received a copy of these terms and conditions of probation.

Further Special Conditions - Continued

- A. You shall be committed to the custody of the Director of the Department of Public Safety for incarceration for a period of six (6) months. You shall be allowed to serve the time on an intermittent basis provided you serve not less than forty (40) days per year. Mittimus shall be determined by your probation officer.
- B. You shall refrain from the use and/or possession of illegal or unprescribed drugs and alcohol.
- C. You shall be subject to random testing of your blood, breath and/or urine for the presence of illegal and/or unprescribed drugs and/or alcohol and shall present yourself for testing within two (2) hours of any request by your probation officer.
- D. You shall continue to attend and fully participate in the Adult Probation Sex Offender Service Program and remain in the program until successful discharge. You will be subject to further polygraph/plethysmograph testing at your own expense and shall waive all confidentiality between your therapist and your probation officer.
- E. You shall maintain full-time employment and not change your employment without permission of your probation officer. You shall not be allowed any employment as a school counselor with the State or a private institution and you shall not be allowed any employment that involves coming into direct or indirect contact with children under the age of 18.
- F. You shall have no direct or indirect contact with any child under the age of 18 without permission of your therapist or probation officer.
- G. You shall have no direct or indirect contact with the victim.
- H. You shall register as a sex offender within forty-eight (48) hours of sentencing with the Hawaii County Police Department and shall be subject to DNA blood samples pursuant to law.
- I. You shall refrain from the purchase or possession of any adult/child pornography. This includes adult movies either on theater/video or television, books and magazines and/or any computer-related pornography.
- J. You shall not frequent any establishment where unsupervised minor children congregate. This includes movie theaters, arcades, carnivals and sports events. This condition may be modified as to attendance of certain movies and sports events subject to approval by your probation officer.

- H. You shall pay a fine of \$200.00 to the Criminal Injuries Compensation Commission within one (1) year of March 10, 2000.
- I. You shall obtain a substance abuse assessment within thirty (30) days and shall begin to follow the recommendations within thirty (30) days of receipt.
