The above defendant having PLED GUILTY in this Court of the crime of violating Section 261.5 of the Penal Code, unlawful sexual intercourse with a minor

is suspended and the defendant is placed on probation for a period of ~~twenty-four~~ ^{thirty-six} months, under the following terms and conditions:

- (X) 1. You shall report monthly in writing on forms provided by the Probation Department on or before the 15th day of each month, and you shall report in person as directed by your probation officer.
(X) 2. You shall keep the probation officer advised of your residence and mailing address at all times.
(X) 3. You shall seek and maintain meaningful full-time employment and keep your probation officer advised of your employer's name and address.
(X) 4. You shall obey all laws and orders of your probation officer.
(X) 5. You shall not leave the State of California without the prior written approval of your probation officer.
() 6. You shall pay a fine and penalty assessment totalling \$ through the Mendocino County Revenue and Reimbursement Department, 175 S. School St., Ukiah, CA 95482 () forthwith () at a minimum rate of \$ () at a rate to be determined by the probation officer.
(X) 7. You shall serve a term in the Mendocino County Jail or other approved California correctional facility of 60 days with credit for 3 actual days heretofore served.
() 8. You shall totally abstain from consuming all alcoholic beverages. You shall not enter any place where alcohol is the chief item of sale, nor shall you purchase, possess, or have under your control at any time any alcoholic beverage.
() 9. You shall not use or have in your possession or under your control any marijuana, narcotics, or other illegal restricted drugs.
() 10. You shall submit to and complete a physical examination and/or chemical testing for the purpose of detecting the presence of alcohol, marijuana, narcotics, or other illegal drugs when so ordered by any peace officer.
() 11. You shall submit to search and seizure at any time of the day or night, with or without a search warrant, by any peace officer, of your person, your vehicle, your property, or any property under your control, with or without cause.

- (X) 12. You shall not associate socially with any person nor be present at any time at any place, public or private, as designated by your probation officer.
- (X) 13. You shall cooperate fully with any form of rehabilitation or counseling program as directed by your probation officer and remain working constructively within that program for the length of time felt necessary by your probation officer.
- ~~(X)~~ 14. You shall register pursuant to California () Penal Code Section 290 () Health and Safety Code 11590 as directed by your probation officer and show proof of such registration within thirty days.
- (X) 15. You shall abide by the general directions of the Mendocino County Probation Department and any other probation or parole department holding a courtesy supervision agreement as outlined by the probation/parole officer.
- (X) 16. You shall pay \$ 200.00 to the Victims Restitution Fund through the Mendocino County Revenue and Reimbursement Department, 175 S. School St., Ukiah, CA 95482.
- () 17. You shall pay \$50.00 to the Criminalistics Laboratory Fund through the Mendocino County Revenue and Reimbursement Department, 175 S. School St., Ukiah, CA 95482.
- () 18. You shall pay restitution to _____ through the Mendocino County Revenue and Reimbursement Department, 175 S. School St., Ukiah, CA 95482, in the amount of \$ _____ or in an amount to be determined, at a minimum rate of \$ _____ per month or at a rate to be determined by the probation officer. In addition you shall pay a 10% administrative fee in the amount of \$ _____ pursuant to Penal Code Section 1203.1.
- () 19. If the fines and penalty assessments specified in this Order are paid in installments, you shall pay a \$30.00 collection fee for each separate fine and penalty assessment, pursuant to Penal Code Section 1205.
- (X) 20. Pursuant to Title 18 of the United States Code, Section 1202(a)(1) Appendix, you are prohibited from possessing any kind of firearm whatsoever.
- (X) 21. You shall ~~sub~~mit to a blood test for evidence of antibodies to the probable causative agent of acquired immune deficiency syndrome (AIDS), in a manner directed by the probation officer.
